### Meet Katelyn Leary, MSW: What brought you to this role?

In my previous position, I had many connections with police officers who were attempting to work with resources in the community to assist those they saw often. I had also been a supervisor for over 12 years and had enjoyed helping build skills and confidence in clinicians. This opportunity provided me the chance to combine several interests, as well as work in a progressive program attempting to meet the needs of various communities.

### What is challenging about your job?

The greatest challenges in this job are still the perceptions around what police officers actually do and where their level of responsibility ends. Tied in with this is the perception of what mental health professionals should be doing and helping change the public perception of how those two can work together to provide communities with the appropriate assistance.
